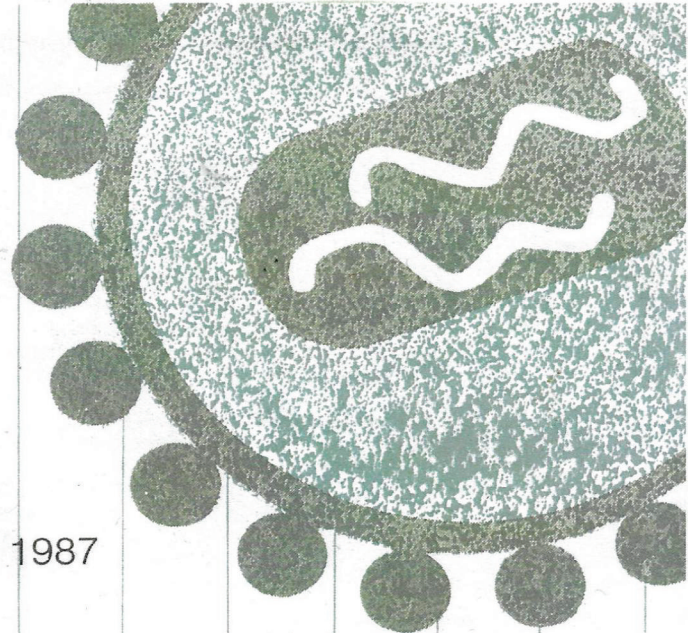

INTRODUCTION

This conference is designed for the medical community and for others with an interest in achieving a greater knowledge of AIDS and HIV. The conference will consist of a number of seminars presented in precise, understandable fashion with plenty of time for discussion between speakers and attendees, as well as opportunities for speakers to interact with one another.

Much is still unknown about HIV infections, and varying points of view have emerged both in the public sector and among health care workers. This conference will platform a variety of medical viewpoints, presented by knowledgeable investigators and clinicians in specific fields of interest.

The main program will conclude with a public policy debate centered around the issues of testing, confidentiality, and the balance between civil rights and the implementation of public health regulations, argued by proponents of the differing points of view.

In addition, dinners and workshops are scheduled to facilitate discussion on specific subject matter in smaller groups.

Pre-registration is mandatory. There will be no on-site registration. Space at plenary, workshop and meal functions is limited. Registrations will be honored on a first come, first served basis.
